Tuition payment arrangements must be completed before the applicant begins classes.

The applicant understands and agrees that Coleman University has the absolute right, exercisable at its sole discretion at any time within the first twenty school days after the student enters the University to terminate the applicant's enrollment. In such an event, the University shall retain only the application fee, and neither party shall have any further obligation under this agreement. Coleman University does not discriminate on the basis of race, color, national origin, sex, disability, or age in its programs and activities.

Upon satisfactory completion of the program, the University offers placement assistance, but there are no guarantees of employment either expressed or implied. The graduate must assume the final responsibility for securing employment.

The applicant agrees to abide by the rules and regulations of Coleman University. Any controversy or claim arising out of, or relating to this contract or the breach thereof, shall be settled by arbitration in accordance with the Commercial Arbitration Rules of the American Arbitration Association, and judgment upon the award rendered by the Arbitrator(s) may be entered in any Court having jurisdiction thereof.

The applicant understands the services to which he/she is entitled as described in the University catalog and that no representations, except as expressed in writing, are binding on either party.
